

Formidable B&B rules and general conditions

These rules and general terms and conditions are binding. Both for Formidable B&B and for those who book and stay at Formidable B&B (the guest).

Prices

Prices include bed linen, towels, (final) cleaning, tourist tax and a "meet and greet drink" on the day of arrival.

Reservations

Reservations are made through the Formidable B&B booking system. Once the reservation has been accepted by the system, the guest will act in accordance with the payment conditions.

The guest can cancel free of charge up to 30 days before arrival. If you cancel within 30 days before arrival, the total reservation will be charged.

Cancellation by Formidable B&B.

The owner of Formidable B&B can cancel the booking due to unforeseen circumstances and will inform the guest as soon as possible. We will propose the guest an alternative offer. If this is not possible, Formidable B&B will refund the deposit. This obligation expires if the cause of the change is attributable to the guest.

Payment conditions

Payments go in two steps:

1. 30% of the booking upon reservation (upon payment your reservation is confirmed). If the guest cancels for 30 days until arrival, the 30% deposit will be refunded.
2. 70% of the booking plus no later than 30 days before the start of the stay.

If you book within 30 days before the start of the stay, you must pay 100% of the booking by return. Payments within this period and with "no show" are non-refundable. We recommend that you take out cancellation insurance.

Any other costs incurred during the stay at Formidable B&B are paid in cash upon departure. We do not have an ATM and do not accept credit cards or checks.

Arrival and departure day

On the day of arrival, the guest can occupy the room from 3 p.m. On the day of departure, the guest must leave the room before 11 am.

Damage and general order

The guest is obliged to take care of all movable and immovable property. This is understood to mean that the guest, and co-residents or others for whom he / she is responsible, do not cause any damage (s), pollution, unnecessary wear and / or load to the inventory and all movable and immovable property present on the property. The guest also undertakes not to cause any nuisance and / or nuisance, in the broadest sense of the word, to the environment. Guests are not authorized to make changes to the layout of the guest rooms or common areas or to remove or change things.

You, the guest, are liable for damage and nuisance caused by you. We, the owners of Formidable B&B, are not liable for damage or injury arising as a result of staying on the site of Formidable B&B, or through the use of the facilities present on the site or in the home. Parents are responsible for their own children at all times.

If guests do not comply with the matters mentioned in the general terms and conditions, the stay period can be terminated with immediate effect. This means that guests leave the room and pay immediately. There is no refund of the already paid accommodation costs.
